**1. Agenda item No-1**

To consider and approve the proceedings of the last meeting held on 13.11.2021.

**Proceedings:**

The Agenda wise proceedings were read out by the Principal and were approved unanimously.

**2. Agenda item No-2**

### 4. Agenda item no-4
